Our reception is on the first floor, to gain entrance please press the **Lovewell Blake** button on the entry keypad on the left hand side of the door.

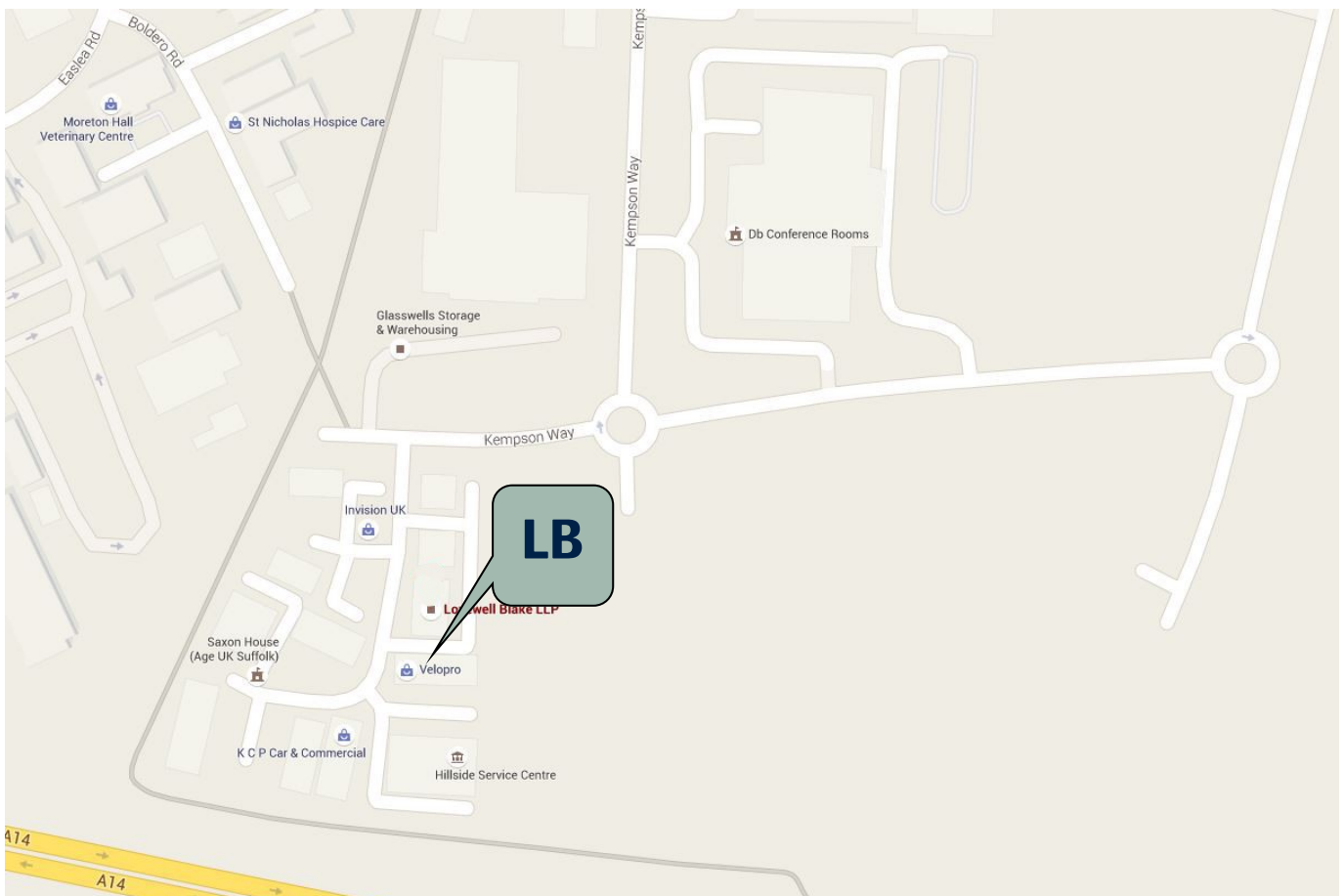
#### How to find us:

Take B1506 to A14 towards Bury St Edmunds. Take exit 44 from the A14. At the roundabout take the second exit and stay on Bedingfield Way. At the roundabout take the fourth exit onto Kempson Way. At the roundabout take the third exit, then turn left into Hillside Business Park and left again into our car park at the rear of the building.

##### From Ipswich via A14
