Disabled access:

We have disabled access at the rear of the building, with a ramp available if necessary. We also have a hearing aid loop in reception.

How to find us:

Please note, whilst our address is Quay Street, due to the new housing development our building and car park are accessed via Blyth Mews. When you enter Blyth Mews we are the first building on your left.

From Bungay (A144)

When you get to the roundabout with the Triple Plea Public House on your left, take the third exit and continue along the A144. At the next roundabout take the first exit on to Quay Street. Follow the road past the garage on your left and turn right into Blyth Mews.

From Southwold (B1123)

Go under the railway bridge and take the next left into Blyth Mews.

From Ipswich (A144)

Take the third exit at the first roundabout, and continue along the A144 to the second roundabout where you take the second exit and continue to the third roundabout. Here you should take the third exit onto Quay Street, then follow the road past the garage on your left, turn right into Blyth Mews.
