If coming from Norwich on the A11, take the first exit on the Thetford roundabout. Turn left on the second roundabout, then take the third exit on the next roundabout into Castle Street, and turn left at Rampart Way. At the bingo hall you should turn left onto Old Market Street.

You will find our office on the left-hand side, and we have a car park which can be accessed through an archway.

Please note the archway can be a bit tight so if you have a large car you may prefer to park on the roadside in front of the office, space permitting.

The entrance to the office is at the front of the building.
